Denise Cohen: Campus Health Clinic Admin., Health Center Board faculty advisor, Nursing instructor. Reviewed the history of the clinic. In 2005 fees were put in place by board of regents. In 2016 we need to raise the fee from \$8 to \$15 to keep up with the demand. Too many students are without insurance, the demand for help is too high. A \$15 fee will cover personnel 40 hrs a week, TB testing, emergency care, flu-coughs-colds-asthma-treatment. As well as acute care, testing for strep and flu, uti, and urine analysis. Currently there is a planned parenthood employee working 19hrs a week, the health center would like to up her an additional 6hrs, plus benefits, her employment costs \$15 an hour. HEALTH CENTER CAN NOT STAY OPEN WITHOUT A FEE INCREASE. Starting marketing campaign, we have not marketed to the new students enough. Needs student government's official support.
